
## **KTM Seat Installation Instructions**





<sup>1</sup> Using an 8mm socket or t-handle, remove the seat bolt from under the rear fender. (**Figure 1**)

<sup>2</sup> Remove the original seat by lifting the rear of the seat up and pull the front of the seat down and back to disengage the seat base from the seat locator bushing on the fuel tank. (Figure 2)


<sup>3</sup> Install your new EE seat by sliding the front of the seat up and forward engaging the seat locator bushing on the fuel tank.

<sup>4</sup> Set the rear of the seat down on the sub frame so that the threaded insert in the seat base (**Figure 3**) engages the hollow seat bushing bolt and collar nut on the sub frame (**Figure 4**)

<sup>5</sup> Insert the seat bolt from under the rear fender and moderately tighten the seat bolt.

Do not over tighten the seat bolt!! Over tightening of the seat bolt could cause the threads to be pulled out of the seat base insert.
